

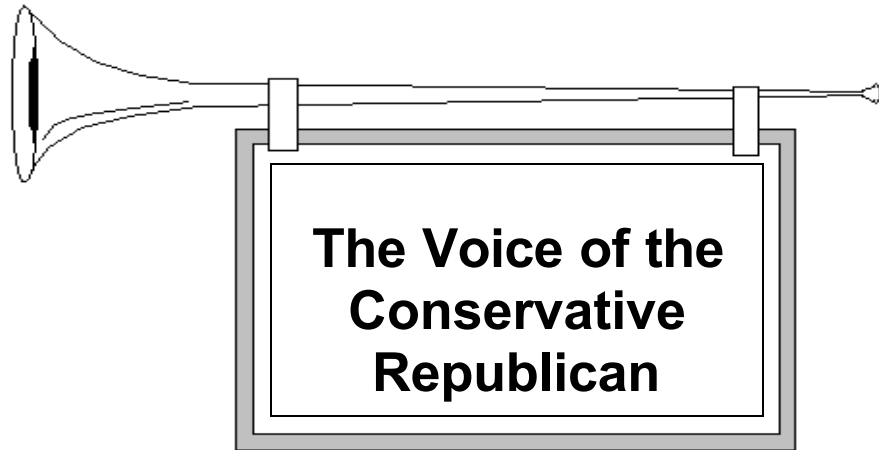

## **GOP Exec. Dir. Touts Changes in Party**

Conservative activists in DuPage County took advantage of the opportunity and grilled a top leader in the Illinois Republican Party, Saturday morning, January 20.

John Tsarpalas, Executive Director, explained party organization and answered some tough questions at TAPROOT's monthly breakfast meeting in the Old Country Buffet, Lombard. The speaker responded with confidence and good humor as the discussion shifted from topics like leadership and money to Bob Kjellander and Kirk Dillard.

Tsarpalas noted that the rules differ between Cook County and the rest of the state. In Cook, precinct workers are appointed and called Precinct Captains. In the rest of the state, they are elected and called Committeemen. One consequence of this is that, in Cook, the list of Republican precinct captains is a secret, which

makes it difficult for outsiders to become active in Republican politics.

Nevertheless, throughout Illinois there are many precincts in need of workers. Since the party ultimately rests on the shoulders of the precinct workers, conservative activists have to step up and become committeemen or at least encourage others to do so. They represent the critical communications link between the people and the party.

The State Central Committee (SCC) recently voted to remove Bob Kjellander from his post in the national Republican organization. He refused to go. Tsarpalas explained that according to the rules, there is nothing the SCC can do. Yet, the Republican National Committee, he assured the group, "got the message." Kjellander's term expires in 2008. In his defense, Tsarpalas noted that Kjellander has raised great amounts of money for the Party.

Dave Diersen expressed concern that Kirk Dillard, Chairman of the DuPage Republican Party Central Committee was excessive in his praise for the Democrat Senator, Barack Obama, who has announced the creation of an exploratory committee for a run for the presidency. Many think it unseemly for the Republican leadership to do "public relations" for Democrat candidates. Tsarpalas answered that he was upset at a vote that his Congressman, (See page 2)

# TAPROOT Christmas Party Bubbles with Optimism

Headliners and celebrities helped to make TAPROOT's annual Christmas Party, Sunday, Dec. 3, the sweet icing on the political cake, where conservatives came to swap stories, plan strategies and just vent over the issues of the day.

The "Conservative Warrior Princess" herself, Teri O'Brien, repeatedly broke up the crowd with a commentary that surely would qualify as a stand-up comic routine. Jim Oberweis stopped by and, after some arm-twisting from Chairman Dave Diersen, consented to tell the group what was on his mind. Rosanna Pulido, head of the local Minutemen, came all the way from Chicago to the Orchard Brook Club house in Downers Grove to update conservative suburbanites on her latest project.

Diersen gave a brief re-cap of TAPROOT's activities during the past year and conducted an election of officers, who retained their volunteer duties for another year. Two issues belonged on the front burner, he said. In order to properly rebuild the Republican Party in Illinois, it has to remove Robert Kjellander from his post as Republican National Committeeman and pass SB600, which allows the direct election of the Congressional district's State Central (**See page 5**)

Mark Kirk, made. When he called to complain, Kirk answered that he received 2000 messages regarding the bill. The lesson was clear, you have to let your representative know what you think.

The SCC also spurred some controversy over its denial of the name "Republican" to the to the Republican Assembly of Lake County, a conservative activist group. Tsarpalas explained that this organization sent a letter to the SCC and asked permission to use the name. The committee denied the use of the name because of its allegedly uncivil behavior, of a campaign of personal harassment against Mark Baubien, and not, as was argued, because the group simply opposed a liberal Republican candidate. Tsarpalas said that the SCC wants to encourage only the highest standards in behavior and noted in passing that TAPROOT conducts itself properly.

Tsarpalas emphasized more than once that the party was in transition from a party of patronage to a party of principle. A hint of this change was expressed when Peter Labarbera, Executive Director of Americans For Truth, a pro-family group, stated that Andy McKenna, Chairman of the SCC, will likely encourage the Party to help out in passing an advisory referendum concerning an amendment to the Illinois Constitution that will protect marriage. Tsarpalas took the job of executive director, he said, to promote conservative principles.

# Tsarpalas Responds to Grilling

Illinois Republican Party (IRP) Executive Director **John Tsarpalas** responded to questions from **Jim Oberweis** and others at an outstanding TAPROOT Republicans of Illinois breakfast meeting Saturday, January 20, in Lombard.

Meeting attendees included DuPage County Forest Preserve Commissioner **Wally Brown**, IRP Vice Chairman **MaryAlice Erickson**, DuPage County and DuPage County Republican Party Treasurer **Gwen Henry**, Chicago Townhall Meeting Coordinator **Rich Johns**, Americans for Truth Director **Peter LaBarbera**, Conservative Activists **Vern McCarthy** and **Bob Schmidt**, and Past TAPROOT Chairman **Dave Pittinger**.

**Tsarpalas** gave an outstanding PowerPoint presentation on the IRP -- he discussed a) the party's structure and operations including differences between Cook County and the rest of the state, b) differences between the IRP and the Illinois Democrat Party (IDP) especially the composition of each party's State Central Committees (SCC), and c) differences between the IRP and the IDP websites.

**Tsarpalas** said only about 7,400 of Illinois' approximate 11,000 precincts have Republican Precinct Committeemen and that about 2,000 of the 7,400 were appointed rather than elected. **Tsarpalas** provided attendees with printouts of his PowerPoint presentation.

In the January 20 GOPUSA ILLINOIS daily email, I included suggested questions to ask **Tsarpalas** during the meeting. **Tsarpalas** read those questions before he arrived at the meeting and answered many of them during the meeting.

**QUESTION:** When will the IRP SCC reverse its January 13 vote to deny the Republican Assembly of Lake County (RALC) permission to use "Republican" in its name, apologize to the RALC, and apologize to each and every RALC member? When will you apologize for your statements against the RALC? If the answer is never, then, what are the next actions that the IRP, the SCC, and you are going to take to drive the remaining conservatives out of the party?

**ANSWER:** Sadly, **Tsarpalas** indicated that the IRP SCC will not reverse its January 13 vote, apologize to the RALC, or apologize to any of its members. Sadly, **Tsarpalas** indicated that he will not apologize to RALC or to any of its members for statements he made about RALC

and its members. Sadly, **Tsarpalas** continued to argue that RALC is divisive. **Oberweis** and I strongly disagreed. However, **Tsarpalas** indicated that the IRP, the SCC, and he do not want to drive conservatives out of the IRP.

**QUESTION:** Last Saturday you said the RALC would be receiving a written confirmation of the vote denying use of the word "Republican." As of yesterday's (Friday, January 19) mail it has not been received. When can the RALC expect to receive it?

**ANSWER:** **Tsarpalas** said the IRP was in the process of revising the letter.

**QUESTION:** In a newspaper article you said the RALC attacked Republican candidates in the November General Election. On page eight of RALC's pre-election news magazine, RALC listed all Republican candidates as being supported as priority one. Which candidate were you referring to in your statement?

**ANSWER:** **Tsarpalas** indicated that he was referring to State Representative **Mark Beaubien**, but he did not provide specifics.

**QUESTION:** How do you reconcile the RNC General Counsel statement that anyone can use the word "Republican" in their organization title with the denial action taken against RALC by the IRP?

**ANSWER:** **Tsarpalas** indicated that IRP lawyers were considering that.

**QUESTION:** What is your response to the Daily Herald's January 20 editorial position that "Illinois Republican leaders may have overstepped their bounds in declaring a conservative Lake County political group can't use the word 'Republican' in its name" and the Illinois Republican leaders' action "is more about retribution?"

**ANSWER:** **Tsarpalas** indicated that the IRP SCC believes it did not overstep its bounds and that its action was not retribution. **Tsarpalas** said that the IRP SCC Victory Committee had voted to deny RALC's application before any of its members became aware of the lawsuit by **Raymond True** against the IRP, but **Oberweis** indicated that at least one IRP SCC Victory Committee member knew of the suit before the SCC (See page 4)

Victory Committee voted.

**QUESTION:** Do you agree that a Republican (for example, Senator, Illinois Republican Senate Whip, and DuPage County GOP Chairman **Kirk Dillard**) praising a Democrat, for example, **Obama**, is far worse than a Republican criticizing another Republican? Please elaborate.

**ANSWER:** **Tsarpalas** indicated that he agreed and that many other IRP leaders also agreed. He indicated that IRP leaders were discussing the problem.

**QUESTION:** When will the IRP issue a report on what happened at the January 13 IRP SCC meeting? What happened at the January 13 IRP SCC meeting? Why was so much of the meeting conducted in executive session?

How did each SCC member vote on the motion to ask **Kjellander** to resign and what reasons did each of them give for their vote? How did each SCC member vote on the motion to deny RALC the right to use Republican in its name and what reasons did each of them give for their vote? Why weren't attendees Senator **Chris Lauzen** or Representative **Paul Froelich** recognized? What did **Andy McKenna** stress in his update?

What did you stress in your post election report?

What did **Maureen Murphy** stress concerning the party's platform and voting integrity? What did **Jim Durkin** report concerning **John McCain**? What did **MaryAlice Erickson** report concerning increasing ethnic representation on the SCC - can **Diersen** volunteer to represent German-Americans?

What is the IRP financial situation - 2006 income, 2006 expenses, 2006 year end assets and liabilities, and 2006 year end net worth? When and where will the next IRP SCC meeting will be? What will be on the agenda? What will specifically be discussed in executive session?

**ANSWER:** Sadly, time did not permit asking these questions, except the one concerning the IRP's financial condition. **Tsarpalas** said IRP raised and spent about \$8 million last year and that IRP's current assets exceed its current liabilities.

**QUESTION:** **Kjellander** rejects the IRP SCC call for him to resign, says he has "done absolutely nothing wrong," says his critics are "disgruntled," and says he is being made into a "scapegoat." Do you want **Kjellander** to resign? Why? If you want **Kjellander** to resign and he continues to refuse to resign, what should the next step

be to prompt him to resign? If/when **Kjellander** resigns, who would be the best person to fill the vacancy and why?

**ANSWER:** **Tsarpalas** indicated that he wants **Kjellander** to resign, but indicated that little if anything can be done to further encourage **Kjellander** to resign. **Oberweis** strongly disagreed. **Tsarpalas** indicated that much of **Kjellander**'s support comes from his fundraising success and that **Kjellander** might have been named Treasurer of the 2008 Republican National Committee National Convention.

**QUESTION:** Why didn't the IRP support the Protect Marriage Project?

**ANSWER:** **Tsarpalas** indicated that things are moving in the right direction for the IRP to fully support the Protect Marriage Project this year.

**QUESTION:** Do you favor or oppose SB600? Why?

**ANSWER:** Sadly, **Tsarpalas** indicated that he opposed SB600.

**QUESTION:** The IRP is clearly becoming increasingly successful in driving conservatives out of the party -- as the IRP's Executive Director, you play a major role in doing that -- history will list you as one who played a major role in driving conservatives out of the party -- how comfortable are you with that?

**ANSWER:** **Tsarpalas** stressed that neither he nor the IRP want to drive conservatives out of the party -- he stressed that **Judy Baar Topinka**'s influence in the party has diminished greatly and that the party is going to be less about patronage and more about principle. #

Committee member.

In spite of the lingering memory of Republican losses, Oberweis struck a note of optimism when he said that Federal District Attorney Patrick Fitzgerald will be, “our ally when he puts Blagojevich behind bars.”

Then he took a swipe at the conservatives’ favorite whipping boy, the mainstream press, saying that conservatives have allowed the press to frame the argument. It continuously defines liberals as ‘moderates’ and mainstream voters as ‘conservatives’. The resulting contrast in terms unfairly puts conservatives in a bad light because they are the real moderates and not the liberals who advocate all kinds of extremist policies.

Rosanna Pulido, the Illinois State Director of the Minuteman Project, announced that she came to the party “to outrage and disgust you.” That is a tall order for a conservative crowd, which has so many things about which to be outraged and disgusted.

She went on to inform the assembly about the latest *cause celebre* cooked up by the immigration amnesty cabal, Elvira Arellano, who has earned fame for defying deportation orders by hiding in a church for “sanctuary”. According to Pulido, the Pastor there is the Rev. “Slim” Coleman, a Communist, who apparently is diligently hewing to the party line, since the Communist Party USA itself is pushing an open immigration policy on its website.

She exhorted conservatives to sign a letter to United States Attorney Patrick Fitzgerald to enforce the law and deport Arellano. A copy may be found on the Minuteman website, [www.illinoisminutemanhq.com](http://www.illinoisminutemanhq.com).

There is no mortal “savior” who will fix the immigration problem. We have to focus on our principles and hold the politicians to the standard, she said.

Talk-radio hostess Teri O’Brien gave the keynote address. Conservatives were disappointed to hear that she no longer has a Sunday program on WLS radio. But she does have a website (<http://www.teriobrien.com>) and sends out a regular e-mail newsletter, where they can enjoy her insights and humor.

With a suggestion of sarcasm, O’Brien brought up the Iraqi Study Report. “You are all counting down the minutes to the release of the report of the Iraq Study Group (ISG) aren’t you? What?! You aren’t on the edge of your seat to hear the suggestions of a bunch of pompous, unelected, superannuated gasbags about what to do about our foreign policy?” she asked.

Anything the report recommends will have to pass a litmus test, she explained. One such test involves the King of the Useful Idiots, Jimmy Carter. “If Jimmuh says something is a good idea, you should do the opposite

thing and you can’t go wrong.... They’ve talked to lots of people to compile their report, as you know. Well, apparently one guy that they thought could share some really valuable insights was none other than Mr. Long Story Longer, John Francois Kerry....”

# “Extremist” Beats “Moderate”
